2025 – 2026 Payment Options & Financial Policies**

North Atlanta Preschool operates as a non-profit organization and relies on registration fees and tuition payments for operating expenses. Prompt payment of monies enables North Atlanta Preschool to maintain its program with the highest levels of quality and standards. The payment policy is based on a child’s commitment to one full school year (Sept. 2025 – May 2026) and payment of the Full Yearly Tuition Fee. Payments are non-refundable and non-transferable. Monthly installments are a courtesy provided to assist in the payment of fees; they are not prorated and require a minimum of one month in advance. Accounts should be current and in good financial standing to remain in the program.

_____ **OPTION #1 –Registration Fee & Full Tuition Payment**

A 2% discount will apply for full tuition payment. Payment will be processed through Tuition Express and is **non-refundable** and **non-transferable**. A minimum **2%** credit card usage fee per transaction will apply.

_____ **OPTION #2 – Registration Fee & Monthly Payments** (Monthly installments are a courtesy provided to assist in the payment of fees over (9) consecutive months) Payments are **non-refundable and non-transferable**. A minimum **2% credit card usage fee per transaction** will apply.

Note: After the registration fee and 1st month tuition is paid, all remaining Tuition Fees are paid monthly on the 1st of the month from **June 2025 – Jan. 2026**. Payments will be automatically withdrawn through Tuition Express and are **non-refundable** and **non-transferable**. Payments **are not prorated, and accounts are required to always be paid a minimum of one month in advance.**

NAPS FINANCIAL POLICIES

Please initial that you have read, understand and agree to the financial policies below.

_____ **Billing Schedule & Information** - Tuition and fees are processed through Tuition Express on the 1st of the month and are **non-refundable** and **non-transferable**. I understand all payments **are processed through Tuition Express**. I authorize NAPS to process tuition payments and fees as outlined in the payment schedule. Should my payment information require updating, I will notify NAPS immediately and provide the required forms.

_____ **Credit Card Usage Fee** – a minimum 2% per transaction will apply.

_____ **Late Payments and Insufficient Funds Fees** – Payments requested to be paid after the 1st of the month, a \$20 late fee will apply. When a payment is returned for insufficient funds, a \$30 fee will apply. Repeated insufficient funds transactions may result in full tuition cash payment only and/or dismissal from the program.

_____ **Refunds** – All payments are **non-refundable** and **non-transferable**. No refunds for short- or long-term absences including illness, inclement weather, travel, or any other reason. In the case of **extended absences, tuition must be paid to reserve your child's place in the class and retain placement in the program**. Failure to do so will result in forfeiture of your child's spot. **NO PAYMENT CREDIT** will be given for absences.

_____ **Withdrawal** – Should it become necessary to withdraw from North Atlanta Preschool, **written notice to the Director is required 30 days in advance and a \$285 early withdrawal fee will apply**. Also, you are still responsible for any tuition or outstanding balances owed to the school while your child attends NAPS. All payments prior to withdrawal are **non-refundable** and **non-transferable**.

_____ **Re-Enrollment** – If a child is withdrawn from the program and returns later in the school year to reenroll, it will be treated as a **new enrollment and the registration fee (\$175) must be repaid**. There will be no credit given from the previous enrollment, including the registration fee, tuition payments or other fees. There is no guarantee that a child will be re-enrolled in the same classroom with the same teachers. Re-enrollment will be allowed on a space-available basis.

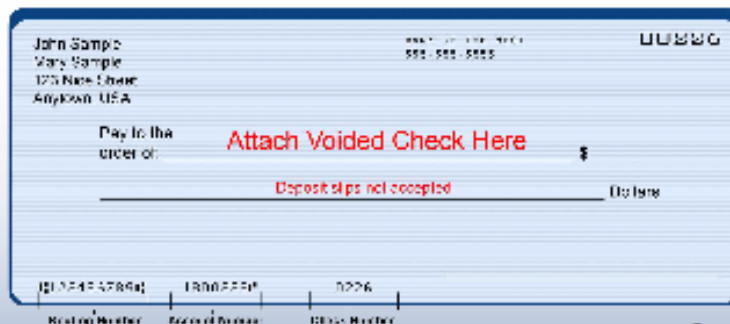
